KIDS CODING

A multimedia adventure course for aspiring coders. Students create animated stories and games while learning programming concepts from SCRATCH, a drag and drop platform that was developed at MIT.



POWER HOUR TUTORING

One-on-one, volunteer-based tutoring program for members in need of academic support. Members are assigned to a specific day with a specific tutor. Parents, tutors and school education coordinators collaborate on each child's academic success throughout the school year.



SUPPORTING Character Development

Members are taught to be productive, caring, responsible citizens through our high-quality programs and a supportive staff who model good behavior. In addition to fostering accountability, we also help young people develop leadership skills, a sense of civic duty and an understanding of the value of giving back to their communities.

SMART GIRLS

A small group program designed to meet the developmental needs of girls in grades 3-8. Each girl is equipped with critical knowledge and skills in the areas of physical health, wellness, mental health, self-esteem and relationships. Girls explore their own and societal attitudes and values as they build healthy attitudes and lifestyles.



PASSPORT TO MANHOOD

A curriculum for adolescent boys ages 11-14 that addresses key areas of development while stressing and promoting positive values and behaviors. Passport to Manhood promotes and teaches responsibility to male Club members at a critical and transitional time in their adolescence. Boys are encouraged to adopt the character virtues that will give them a positive head start in their journey to manhood.

HONOR GUARD

The Honor Guard performs at community events such as the Old Timers Dinner, Greenwich High School sporting events, Memorial Day and Fourth of July ceremonies. All grades are welcome to participate in the Honor Guard. Members learn teamwork, leadership, character development and good citizenship.



CAMP SIMMONS

Camp Simmons is a sprawling 77 acres of pure wilderness on Lake Avenue in Greenwich. It features an outdoor swimming pool, archery range and a pond for boating and canoeing. Campers participate in special events and themed days like Holidays in July, Olympics and weekly fishing derbies.

The Boys & Girls Club of Greenwich celebrated the 50th Anniversary of its Youth of the Year Program on Thursday, February 8, 2018. **Domenica Echeverria**, a junior at Trinity Catholic High School, was the 2018 BGCG's Youth of the Year and went on to become the 2018 CT State Youth of the Year. Domenica was the first Club member to be named the State of Connecticut Youth of the Year in 27 years. **Jean Witmer**, who joined the Board of Directors in 1992 and became board chair in 1999, was honored as the Champion of the Year Award recipient.

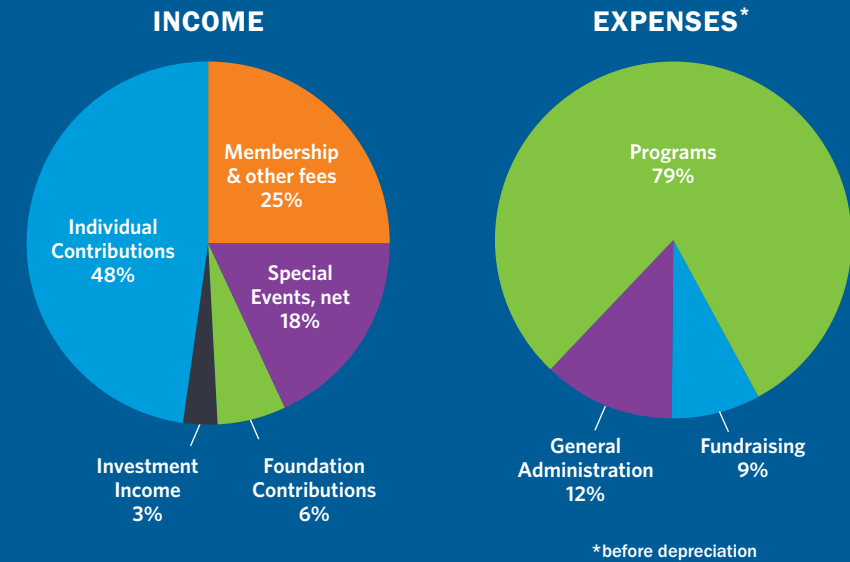
